

Statistical Information:

The Graphed items are charges and arrests made, by the Winston Police Department and sorted by year.

Cases were compiled out of data from our Records Management System (Tiburón). When you peruse this information, you will notice a difference between the number of cases (reports) taken and the number of charges (offenses) on that same year. This will occur for several reasons. For example, when a report is taken for rape, you may charge the suspect with several criminal charges like sex abuse, rape, kidnap, sodomy. The case report will show that case as rape. Another instance may be that although a case was taken for theft we have no known suspect to charge, or the case is still in the investigation process.

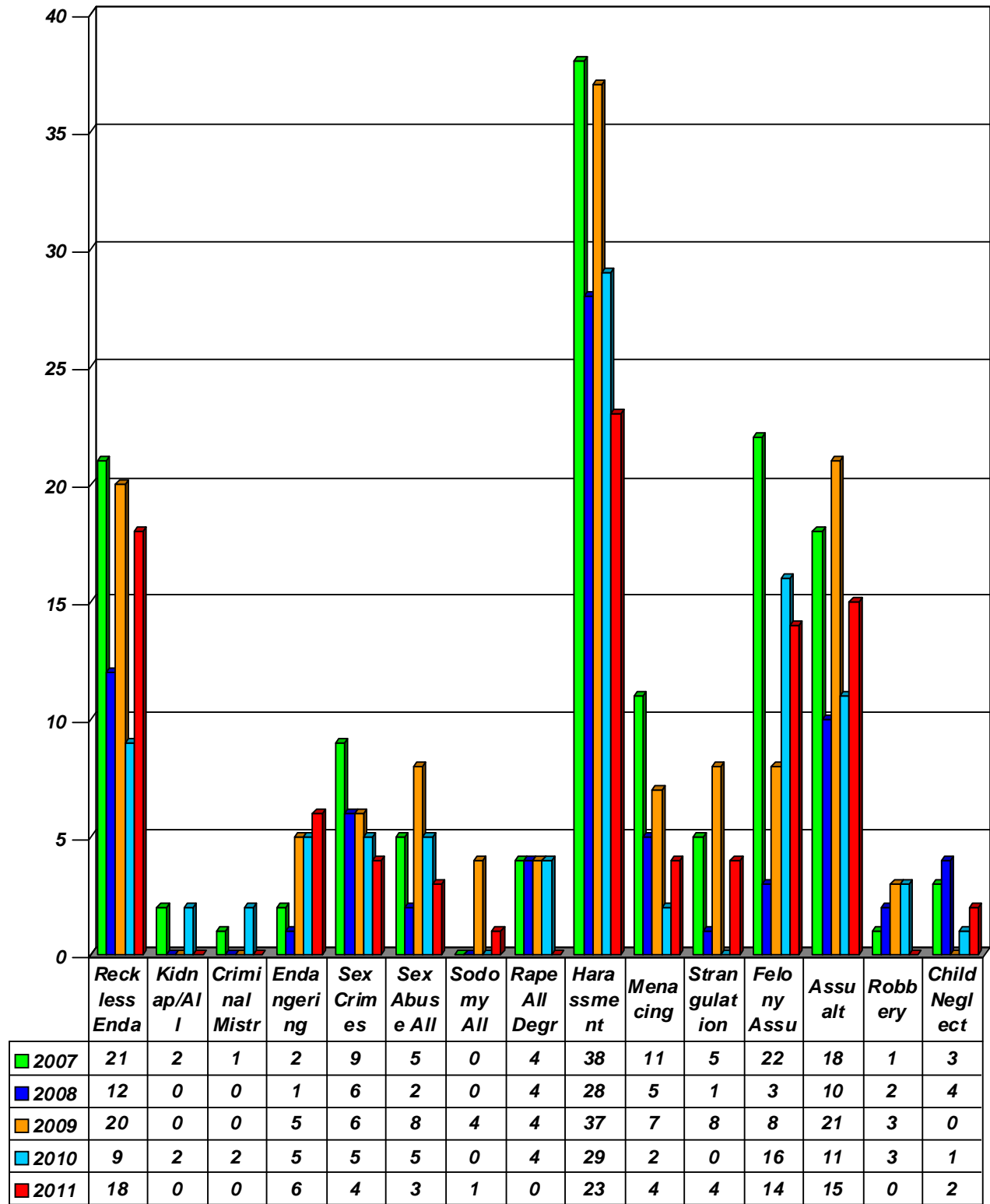

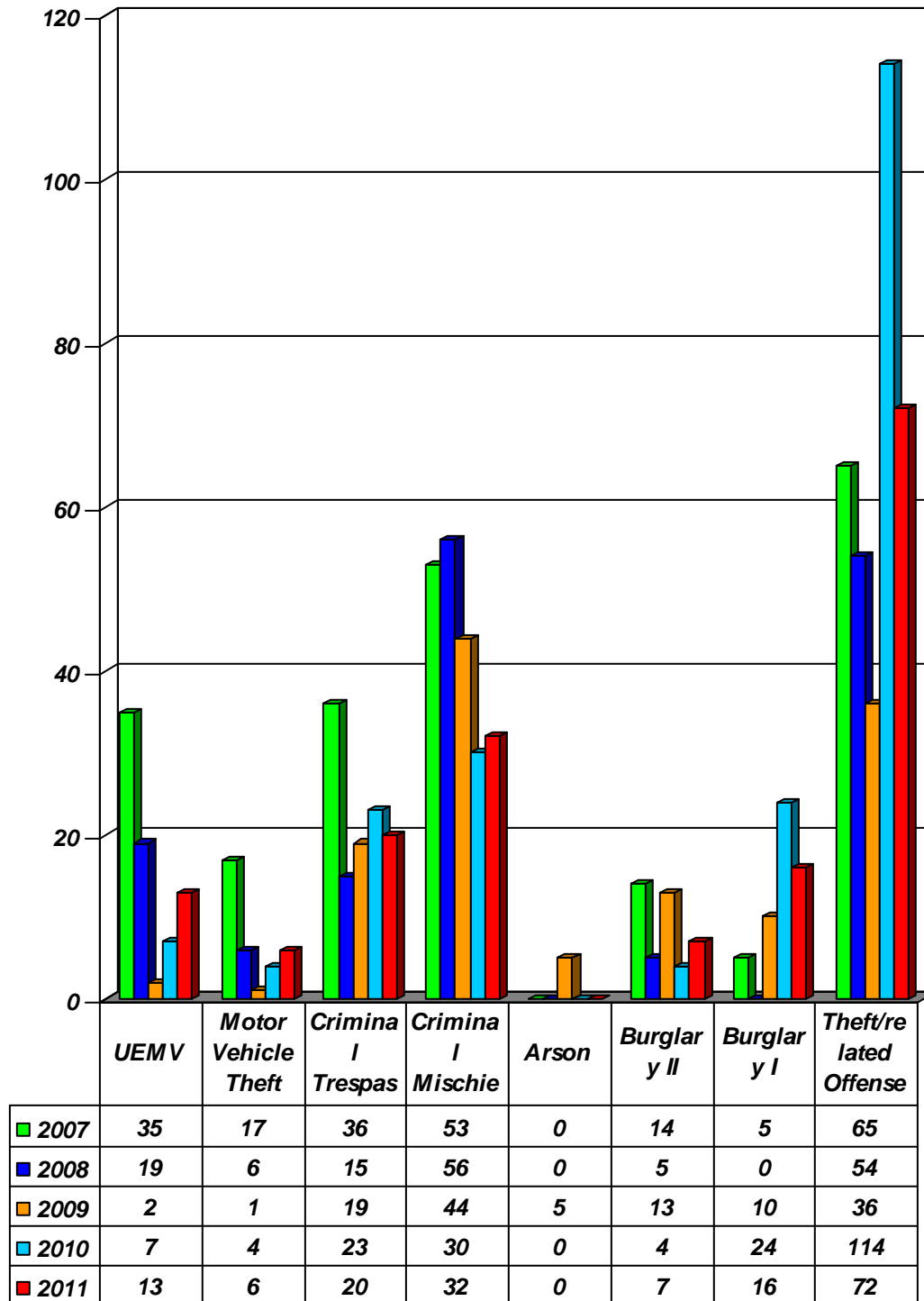

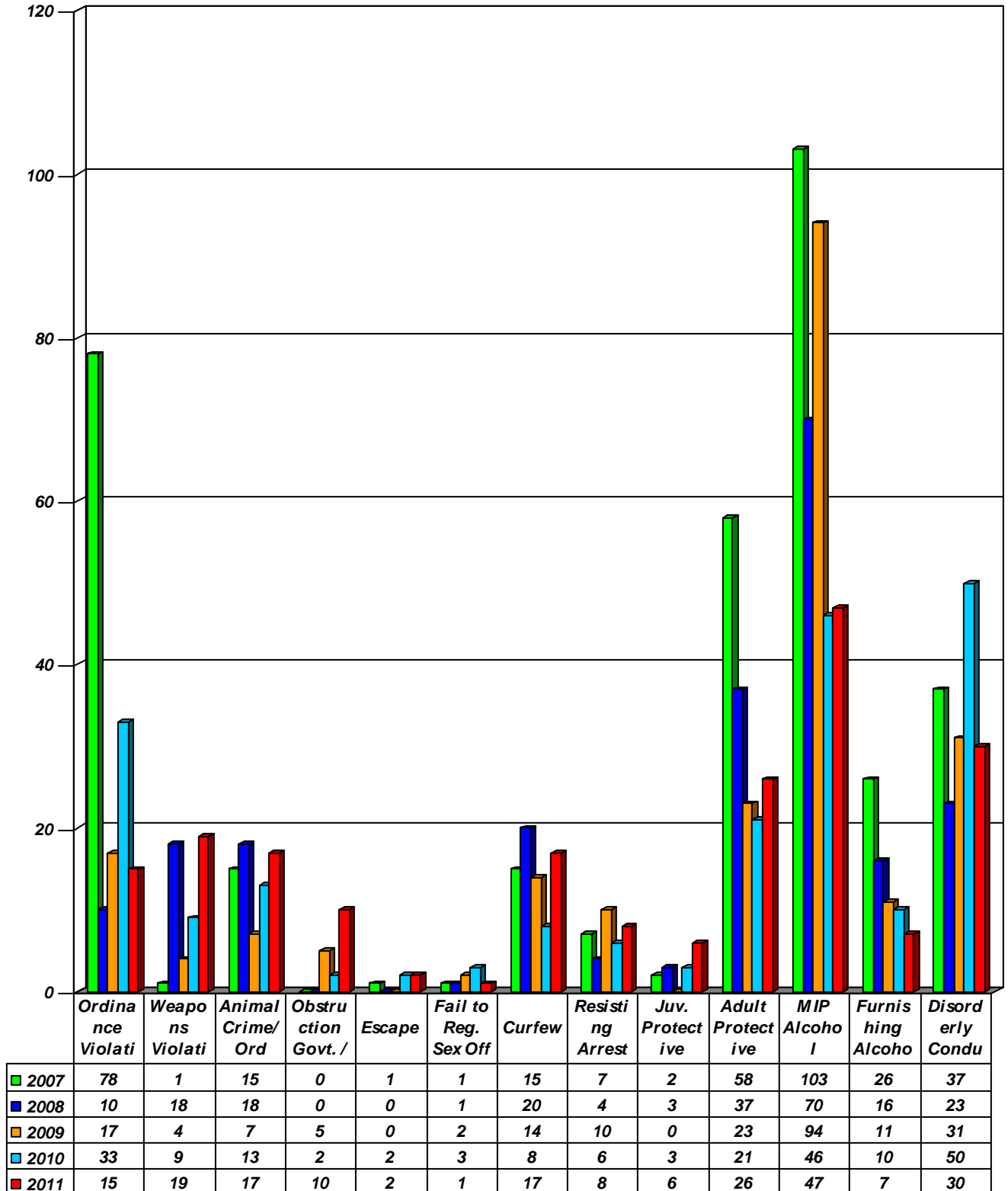
Person Crimes Arrests



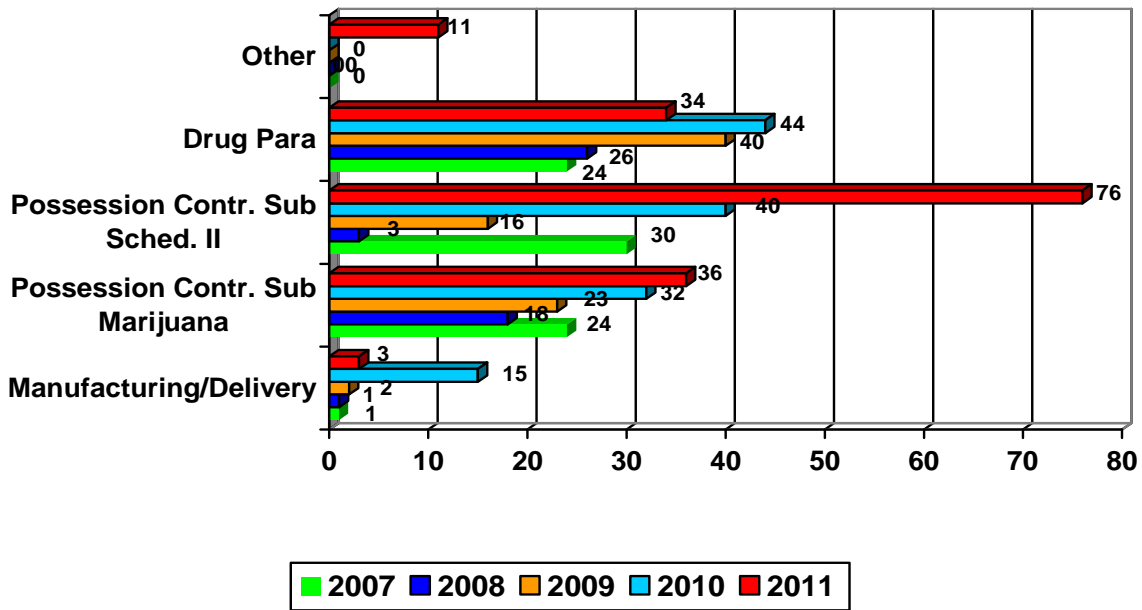
Property Crimes Arrests



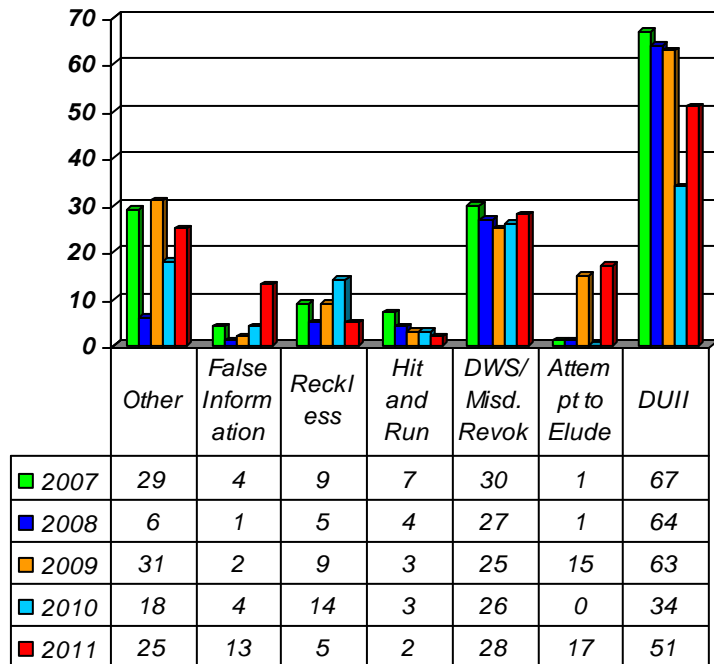
Public Order Offense Arrests



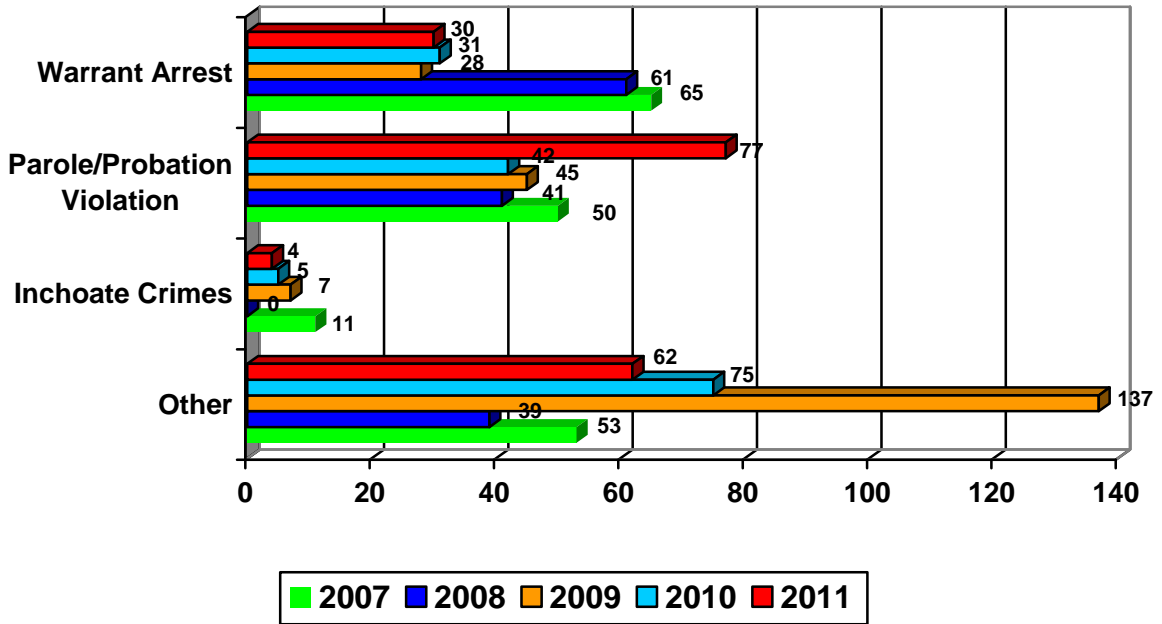
Drugs and Related Offense Arrests



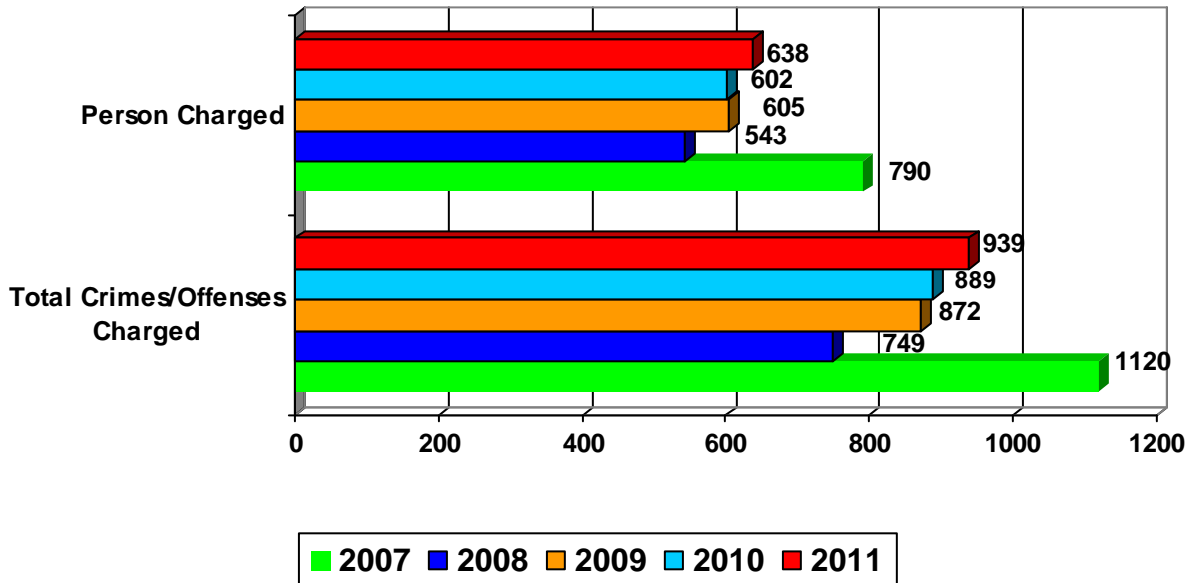
Traffic Related Arrests



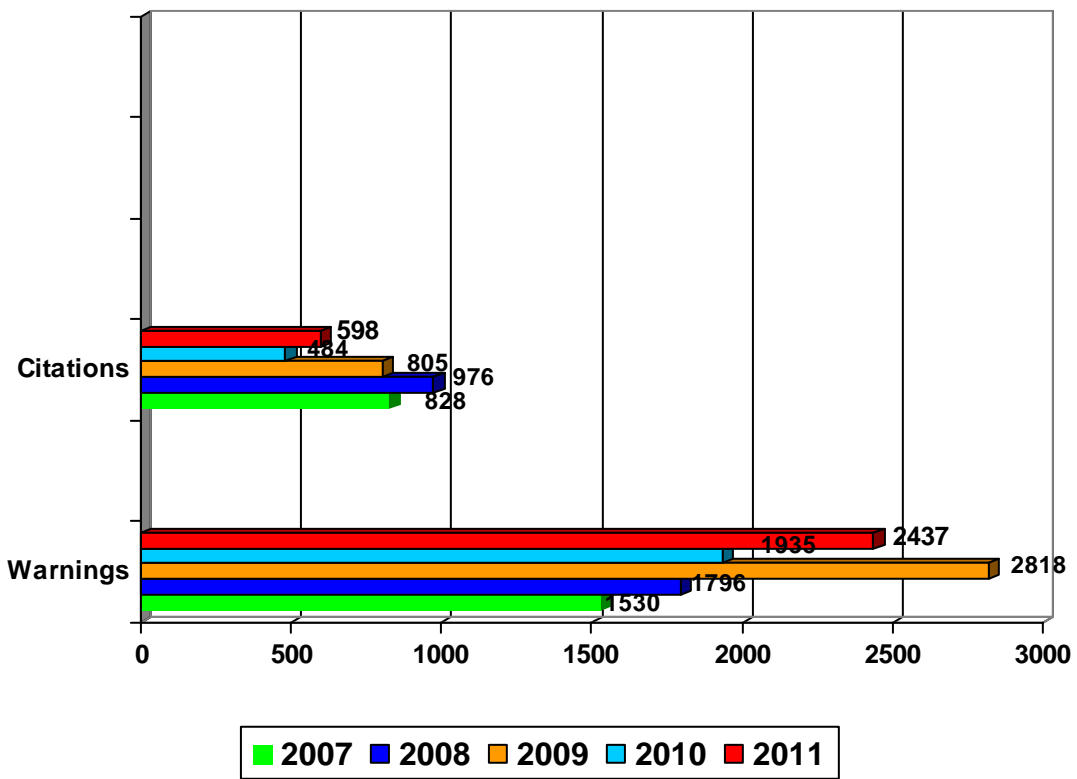
Other Arrests for Offenses/Crimes
